2. Superintendent-Director's Report

Information: A. Superintendent-Director Update

- Once again, Monty Tech has been informed by SkillsUSA that one of our students, junior Nadia Martowska, has been chosen the winner of the 2025 Massachusetts Trading Pin Design Contest. This is the fourth year in a row that Monty Tech has won the state Trading Pin contest.
- On January 22nd, members of the Monty Tech administrative team met with Steve Pettit from Blue Spruce Technologies to discuss the development of a policy that addresses the use of Artificial Intelligence by students. In developing a policy, it was suggested that the essential framework should consider three primary elements Student Safety, Student Ethics, Teacher Empowerment
- STEP Explore Program, Spring 2025 Monty Tech is proud to announce our second year of targeted career training, serving young adults with disabilities.
- Monty Tech is ready to move forward on the renovation to replace the existing spray booths in the Auto Body & Collision Repair Program. Poulin Construction of Sterling, MA earned the bid with a proposal of \$739,900. Funds will be distributed from the following accounts: Previously Accepted Anonymous Donation \$180,330, WCTF Donnelly Grant \$340,100, Perkins Grant \$100,000, and #1378 Instructional Equipment \$119,470
- On January 30th, Assoc. Commissioner Bennett visited MVP Academy with her team from DESE to tour the facility in order to determine if there was a foundation for success to move forward on the plumbing program. The overall sense is that the visit went well, and we look forward to hearing from her soon.
- BESE/DESE/MAVA Admissions Policy Update
 - During the January 27, 2025 BESE Vocational Admissions Subcommittee meeting, DESE provided an analysis of the "disparate impact" of the typically used selective criteria. In presenting that data, DESE offered a conclusion that Academics and Student Interview demonstrated a "significant disparity". Then, during the January 28, 2025 Monthly BESE Meeting, the Chair of the subcommittee suggested that BESE & DESE begin to work to develop a new admissions policy to be presented at the Feb. 25th monthly meeting.
 - MAVA is currently soliciting input from the membership and meeting with officials at the State House and Executive Office of Education to see where a "new policy" would land.
- Superintendent Browne shared information regarding a variety of FY26 proposed vocational-related legislation.
- Additionally, Superintendent Browne provided the Committee an overview of DESE suggested responses regarding ICE activities related to schools.
