2. Superintendent-Director's Report

Information: A. Superintendent-Director Update

- Dr. Harrity spoke about all the effort that went into holding a senior prom for the class of 2021 on Saturday, May 22nd. There were two sessions, one from 4:00 5:30pm and one from 7:30 9:00pm.
- The 50th Annual Commencement Ceremony was held Thursday, May 27, 2021.
- Monty Tech was awarded a Rapid Reemployment Grant in the amount of \$30,000.00. Monty Tech School of Continuing Education will provide NO COST CNA training program for 10 people in need of employment due to COVID layoffs. The program is a collaborative effort with North Central Career Center, who would qualify for a portion of the award (\$1,000+ per student), for their work in recruitment of participants and employment placement of program completers. This 150-hour training program will result in a number of certifications to ensure program graduates are prepared to enter healthcare careers. Certifications will include: OSHA 10, Basic Life Support for the Healthcare provider (CPR and AED), First Aid, Home Health Aide, and Certified Nurse Assistant.
- Diamond Turf removed the infield dirt and lowered the baselines. We purchased 65 ton of new red infield mix and leveled the surface. This will be the first phase of getting the field in everyday playing condition. Once school ends, Diamond Turf will come back and add loam and seed to the infield grass.
- On Friday, May 21st The Monty Tech Welding Program was approved as a Massachusetts Pre-Apprenticeship Program. Just having this designation opens us up for grant opportunities. They consider every Junior and Senior in the program a Pre-Apprentice, and will issue graduates certificates from the Massachusetts Executive Office of Labor & Workforce Development, Division of Apprenticeship Standards, documenting their completion of a Pre-Apprenticeship Program and hours. This will help if graduates find work with an Approved Apprenticeship Provider - who will then recognize these hours of training and advance them in the apprenticetraining program and on the pay scale.
