2. Superintendent-Director's Report Information: A. Superintendent-Director Update

- A 2-year agreement was reached between Monty Tech and NEADS, Inc., with regard to enhancing educational opportunities for our students enrolled in the popular Veterinary Science program, and for use of the clinic as a site designated to provide care for NEADS dogs.
- Superintendent Harrity reviewed this week's COVID map.

- On November 18, 2020, Senator Anne Gobi emailed to inform us that the school had been chosen to participate in the first phase of the Abbott BinaxNOW, on-site COVID testing, announced by Governor Baker on that same date.
- The Department of Elementary and Secondary Education has decided to continue the review and discussion of vocational school admission policies. Regulation changes as a result of this work are proposed for this school year.
- Recently the United Way of North Central Massachusetts and AIS, a Leominster-based furniture manufacturer, contacted Monty Tech, offering to donate masks for all students, faculty and staff. Through its Sew the Masks campaign, AIS has donated 1,700 masks to Monty Tech, and to other area schools, all Massachusetts poll workers, and of course health care workers and first responders.
- Safe and Supportive Schools Grant Amount Requested: \$10,000. To address health and safety concerns our students and staff may be facing in these challenging times, we will identify and implement strategies and supports that reassure our students and staff that their social and emotional safety is just as important as their physical safety. Collaborating with community service agencies, we will address efforts to create a healthy school climate.
- Career Technical Initiative Grant Amount Requested: \$125,000 Date Submitted: 11-20-2020 Description of Request: To provide training opportunities for adult learners at NO COST in the Welding and HVAC/Oil Burner Technician trades. The proposal is a collaborative effort with North Central Career Center, who would qualify for a portion of the award (\$1,500 per student), for their work in recruitment of participants and employment placement of program completers. This 250-hour training programs will result in a number of certifications to ensure program graduates are prepared to enter the welding and HVAC industries upon completion. Job placement is an important component of the proposed program.
