2. Superintendent-Director's Report

Information: A. Superintendent-Director Update

- Superintendent Harrity reviewed this week's COVID Map
- COVID Relief Funds The FY21 Corona Virus Prevention Fund provided an allocation to Monty Tech in the amount of \$69,550.

- Senator John Cronin, Massachusetts State Senator On January 20, 2021, the Monty Tech leadership team met with newly elected Senator John Cronin, District Coordinator Susan Templeton, and Chief of Staff Kevin Bowe. Senator Cronin was interested in hearing about Monty Tech, and our efforts to train a regional workforce.
- The Monty Tech leadership team has met on several occasions with DESE representatives from the Office of College, Career and Technical Education and the Center for Educational Options. These representatives have stated their goal as follows: "To determine if there is a disparity in who is applying (awareness gap), as well as who is enrolling (opportunity gap), providing a broader view of CVTE equitable access concerns."
- Superintendent Harrity reviewed the MA Vaccine Distribution chart and shared that schools are in phase two, group 3.
- At the January 26, 2021 DESE Board meeting, the Board heard and approved the Commissioner's proposed modifications to the Competency Determination requirements in ELA and mathematics for students in the class of 2021 who have not yet earned the CD.
- On February 1st, Monty Tech signed a MOU with the Institute for Health and Recovery (IHR), in an agreement to collaborate with IHR to expand and enhance treatment and recovery services for adolescents, transitional aged youth (12-20), and their families.
- On February 3rd, the Wall Street Journal published an article highlighting the efforts vocational schools have made to adjust instruction, due to the pandemic. Two vocational schools were featured in this national article/podcast: • Ignite Technical Institute in Brooks County, TX • Monty Tech, Fitchburg, MA
- The Monty Tech Athletics Department is now registering student-athletes for the Fall II season. This season was created to allow districts who were concerned with the immediate start of sports in the fall, an opportunity to delay until February. Fall II activities will occur from the end of February through April 23, 2021.
