2. Superintendent-Director's Report

Information: A. Superintendent-Director Update

- Following the success of the first STEP program to provide workforce training to young adults with disabilities, a fall STEP Explore Program was offered to keep the momentum going. This 4-week model was graciously funded by CAPS Collaborative. However, Monty Tech and its partners were fully committed to reoffering this workforce training opportunity. Thus, Monty Tech immediately submitted a second Employment Program for Young Adults with Disabilities Grant with hope for continuing our success, and Monty Tech was notified by CommCorp that it was awarded \$132,900 to provide further training this spring. While we continue to partner with CAPS Collaborative, we will seek out additional community partners to help us identify potential participants for this program.
- On December 5th, Superintendent Browne met with the 26 members of the North Central MA Chamber of Commerce Community Leadership institute along with the Program Director of MyTurn and the President of Fitchburg State to discuss "Leadership in Education".
- Following a hearing with the Atty. General's office, Monty Tech was required to rewrite its RFP for the auto body booth installation to increase the likelihood that more companies could submit bids. The RFP is not reposted with filed sub bids due on January 23rd and general bids due on January 30th.
- Working closely with Andrea Corrado (PN Program Director), Donna Byron of Phillipston developed a committee with a goal of supporting PN students with financial gifts up to \$500. Initial disbursement was made on December 4th with the goal of distributing all awards prior to the holiday break.
- The effort to finish the renovations at MVP Academy is in high gear as individual spaces near completion. For example, the floors and painting are done in Electrical as their booths are being installed and equipment moved in. Once all Electricals' equipment is removed, we will begin the floor work and final painting in House Carpentry. Additional floors and FRP are being installed in the bathrooms. Exterior work includes a masonry pour for the already installed stair frames as well as roofs on both entrances. The final exterior project will result in the installation of the ADA lifts.
- While the MVP students continue to help with the renovations, a concern regarding the addition of the Plumbing program in the fall arose as the MVP Partnership was informed that we missed the application date. A report was submitted to DESE requesting an extension based on the fact that DESE did not properly update its website to notify prospective applicants of the start of the application process. The district is hopeful that DESE will reconsider the current determination to disallow an extension of the application process for the simple reason that preventing the establishment of the MVP Plumbing Program only has one effect which is the loss of workforce training for 40-44 students from Fitchburg, Gardner and Narragansett, many of whom are members of special populations. At this time, DESE plans to visit the MVP facility in order to assess if there are any potential road blocks to the launch of the program.
